

The IQAC shall have the following functions:

- To develop and apply quality benchmarks for the various academic and administrative activities of the University.
- To create learner-centric conducive environment for quality education and Faculty maturation and adopt the required knowledge and technology for participatory teaching and learning process.
- To develop a full proof feedback system to get responses from the students, parents and other stakeholders on quality-related institutional processes.
- To disseminate information on the various quality parameters of higher education.
- To organize inter and intra institutional workshops, seminars on quality related themes for promoting the quality.
- To act as a nodal agency for coordinating quality-related activities including adoption and dissemination of good practices.
- To develop and maintain Institutional database through MIS for the purpose of maintaining/enhancing the institutional quality.
- To prepare Annual Quality Assurance Report based on the quality parameters/assessment criteria developed by the relevant quality assurance body (like NAAC, NBA, UGC, AICTE) in the prescribed format.
- To host in the website window the institutional report on its activities as well as the AQAR.

The terms of reference to the Committee are as under:

1. The Committee shall meet as often as it deems necessary for suggesting the measures for the enhancement of quality in the institution.
2. The Committee shall follow its own procedure for improving academic performance of the University.
3. The Committee shall coordinate with other academic bodies for improving academic performance.
4. The Committee shall take all such action as it deems it necessary for sustainable academic growth.
5. The Committee shall coordinate with the sister Universities, Departments of Higher Education, NGO'S and other autonomous institutions for getting valuable input for formulating sound academic policies.
6. To collaborate with other stakeholders of Higher Education for quality evaluation promotion and sustenance.
7. Such other allied and incidental issues relating to the quality enhancement.

The Committee shall remain in force till it is reconstituted or modified.
