TUMKUR UNIVERSITY (AMENDMENT) REGULATIONS GOVERNING POST-GRADUATE DEGREE PROGRAMMES

Offered under Semester Scheme with Choice Based Credit System (CBCS) -(2014-2015)

(As per Section 44(1) of Karnataka State University Act 2000)

Preamble: The regulations Regulations Governing Post-Graduate Degree Programmes offered by Tumkur University under Semester Scheme with Choice Based Credit System (CBCS), 2014-2015, was earlier notified on 02.06.2014 (Vide notification No. TU/AC/2014-15/671) with an aim to consider and adopt Semester Scheme, Choice Based Credit System (CBCS), Flexibility in Curriculum Development and Examination Reforms in terms of adopting Continuous Evaluation Pattern by reducing the weightage on the semester-end examination so that students enjoy a destressed learning environment.

However, after declaration of the results of the post-graduate examination, a candidate who feels that his answer script has been valued unfairly is not able to apply for revaluation, as there no provision for re/challenge valuation.

Hence, to provide a fair opportunity for such candidates, the Academic council and Syndicate in meetings held on 16.05.2019 and 20.05.2019, respectively, approved to include the provision for challenge valuation in the existing regulations. In this context, the following amendments in the regulations are proposed.

1. Short title and Commencement:-

- (1) These regulations may be called the Tumkur University (Amendment) Regulations governing post-graduate degree programmes offered under semester scheme with Choice Based Credit System (CBCS) -(2014-2015).
- (2) They shall come into force from the date of assent of the Governor and Chancellor.
- 2. Amendment of Regulation 24: In the Regulations governing the post Graduate programmes under Semester scheme with CBCS, in Regulation 24, after clause 24.13, the following shall be inserted namely, -.

"24.14: Challenge Valuation: After declaration of the results of the post-graduate examination, a candidate who feels that his/her answer script has been valued unfairly can, after remitting a fee prescribed by the University from time to time shall request the Registrar (Evaluation) for a fresh valuation of his/her script. The Registrar (Evaluation) may, with the prior permission of the Vice-Chancellor, ask a subject – specialist from among the panel of examiners approved already or specially by the Syndicate, to evaluate the concerned script. The marks awarded in such a challenge-valuation shall be overriding the previously – announced one whether or not advantageous to the candidate."
