Eligible Candidates may apply by Payable application fee (SB Collect) online (by paying Rs: 400-00 (Rs. 200-00 for (SC/ST/Cat-I) Application format can be downloaded from university website filled application has to be submitted to the department. The detailed prospectus related to PG-/MBA (Finance) admission and the instruction to fill the application can be obtained the respective departments.

Filled-in applications(printed) with necessary enclosures should reach the department "Chairman, Department of studies and research in Business Administration, Tumkur University, Tumakuru" on or before 03.02.2024 (5:00 pm)

Admission to PG-MBA (Finance) will be made through Entrance Examination. Reservation of Seats will be as per the government orders issued from time to time.

The merit list will be prepared on the basis of the marks obtained in the Post Graduate Common Entrance Test Conducted by Tumkur University without taking the marks obtained by the candidates in the qualifying examination. The qualifying examination marks is considered only for eligibility.
