

Universities/Colleges will not accept Anti Ragging Undertaking by students in Hard/Printed copy/Affidavits. (Please note that the student is not required to print & sign it as it used to be in the earlier case).



- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- · Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- · Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarringsfrom appearingsin-any test/examination or other evaluation process.
- · Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festivalieto.
- Collective punishment: when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.
