Applications are invited from highly motivated and eligible candidates in a prescribed application format for the post of a **Junior Research Fellow (1 No.)** in the Department of Studies and Research in Chemistry, University College of Science, Tumkur University, B H Road, Tumkur, Karnataka-572103, India, under the research project entitled “**Design and development of iron-based heterogeneous catalysts for applications in organic syntheses**” sponsored by DST-SERB, New Delhi.

ELIGIBILITY: MSc in Chemistry/Organic Chemistry from any recognized University/Institute with at least 60% marks in aggregate or 6.5 CGPA on 10 point grade scale. Preference will be given to those candidates who qualified in CSIR-UGC-JRF/NET-LS examination or having a valid GATE score.

Desirable Qualification: Knowledge of basic practical skills in chemical synthesis and characterization of simple organic or organometallic compounds.

Selection procedure: Through an interview before an expert committee. The date and time of interview will be intimated by email/post to the shortlisted candidates only.

Monthly Emoluments: Rs. 31,000/- (Consolidated) + HRA

Nature and Duration of the employment/ project: Temporary for 3 years

Terms and conditions:

1. Candidates are required to appear for the interview with a photocopy of the application form, two passport size photos, curriculum vitae, testimonials and all relevant certificates in original with a one set of self-attested photocopies of all certificates.
2. No TA/DA is permissible to the candidate for appearing in the interview.
3. The appointment will be till the end of the project tenure. However, the candidate may be discontinued any time by giving a one-month prior notice or if the performance is not found satisfactory. Selected candidates will not be permitted to claim for any regular/part time appointments in this institute or any other institutes during this period.
4. The above position is purely temporary and continuation of the fellowship is subject to the satisfactory performance and review after every 3 months and availability of fund under the project.
